



Terry White Chemists Curash Baby Bonus Card

Terms and Conditions

These are the current terms and conditions of the Terry White Chemists Curash Baby Bonus Card program and may be amended by Terry White Chemists from time to time.

In these terms and conditions:

'Bonus Product' means a Qualifying Product which may be obtained by a Member through a Terry White Chemists store by the redemption of Credits in accordance with these terms and conditions;

'Bonus Card' means the Terry White Chemists Curash Baby Bonus Card that Terry White Chemists issues to a Member;

'Credits' means credits awarded to Members pursuant to these terms and conditions;

'Member' means a person who is a member of the Bonus Card program;

'Program Period' means the period from 8 August 2011 to 30 June 2012;

'Qualifying Products' means those products specified in these terms and conditions on which Credits may be earned.

Terry White Chemists reserves the right to make changes to the operation of the Bonus Card program or these terms and conditions or to terminate or suspend the Bonus Card at any time

Changes will be posted on this website and will be available at Terry White Chemists stores. Any change or termination will not affect Members entitlement to redeem Bonus Products existing at the time of the change or termination.

Membership

Membership of the Bonus Card is open only to individuals and any application for membership may be accepted or refused at the discretion of Terry White Chemists

By using the Bonus Card or claiming any Bonus Product, the Member agrees to be bound by these terms and conditions.

The Bonus Card remains the property of Terry White Chemists and must be returned on demand. It is not a payment card and cannot be exchanged for cash. The Bonus Card is valid for use only by the Member during the Program Period and is not transferable.

A member is responsible for the security and use of their membership Bonus Card. In the event of loss, theft or unauthorised use of the Bonus Card, any Credits earned are not replaceable.

Members must not improperly use the Bonus Card or supply or attempt to supply false or misleading information to Terry White Chemists. Members must sell or transfer any Credit or benefit other than in accordance with these terms and conditions.



Terry White Chemists may suspend or terminate a Member's Membership and/or the right of the Member to use the Card or reverse or cancel the Member's Credits or any part thereof for failure to comply with these terms and conditions.

Credits

Credits may only be earned and/or redeemed in accordance with these terms and conditions.

To earn a Credit, Members must purchase a Qualifying Product from a Terry White Chemists store during the Program Period and attach the receipt from the purchase to the Bonus Card. Terry White Chemists reserves the right to require copies of receipts showing the purchase of Qualifying Products

Credits will not be awarded in relation to any purchases that are cancelled, refunded or returned and any Credits that have been incorrectly awarded or awarded in relation to cancelled, refunded or returned products may be cancelled or deducted. Terry White Chemists reserves the right to reverse or cancel any Credit awarded other than in accordance with the terms and conditions at any time.

Credits are only valid during the Program Period and will not be able to be redeemed for Bonus Products after the Program Period.

Credits cannot be credited or redirected to any other program offered by Terry White Chemists.

Bonus Products

For Bonus Cards to be accepted as completed, the Bonus Card must have the Member's name, address and phone number. Terry White Chemists reserve the right to validate the authenticity of the information provided by the Member.

The number of Credits that must be redeemed to receive a Bonus Product is determined by Terry White Chemists and may change at any time.



Not all Qualifying Products are available in all Terry White Chemists stores or may not be available at a specific Terry White Chemists store at the time of redemption.

The terms and conditions applicable to a Bonus Product redemption will be those in force at the time the Credits are redeemed for that Bonus Product.

Terry White Chemists does not give any warranty or make any representation in relation to the price or value of any Bonus Product.

Personal Information

Terry White Chemists will collect the personal information of Members and use the personal information in accordance with the Terry White Chemists privacy policy. The Member consents to their personal information being used by Terry White Chemists as part of the business of Terry White Chemists in accordance with the Terry White Chemists privacy policy and for the purposes of:

- (a) improving customer service by means of research, marketing, product development and planning;
- (b) direct marketing of products or services or the products or services of third parties; and
- (c) any third party who might be located outside Australia providing services to Terry White Chemists in connection with the administration or operation of the Bonus Card program; and
- (d) being disclosed to the supplier of the Qualifying Products to Terry White Chemists.

These terms and conditions are governed by and will be construed in accordance with the laws of the State of Queensland, Australia and the Member submits to the exclusive jurisdiction of the State of Queensland.
